3. Competitors must supply their own equipment and cooking ingredients. All cooks must have a fire extinguisher at their site.
4. Competitors may arrive and set up booth on Saturday, Feb 27th 2010 from 8:00am until 10:00am.
5. Competitors must adhere to RI State Health and Sanitation Regulations.
6. Competitors may not sell their chili or other food / beverages.
7. RISWCFC will supply sampling cups and spoons.

\*Note that ICS Cooks are NOT required to compete in the People's Choice for this event. However remember that:

More Chili means more fun!

The Charities and General Public will have a better experience

You will also be competing with Prov/Metro Cooks & Chefs who enter any ICS Divisions individually, and that will contribute to the competitive spirit of this event!
